

## AutumnRidgeatManchester.com Rules & Regs Supplemental

Dryer Vent Cleaning: Certification must be provided to Management company annually

ANIMAL PENS, RUNS, or CAGES: as external structures are not permitted.

**ARTIFICIAL GRASS:** Installation of any artificial grass on any lot, porch, deck, or patio is not permitted.

**CANOPIES:** with framework anchored to the ground are not permitted.

**DECKS:** are not permitted.

**DECORATIVE OBJECTS:** are permitted and include baskets, flower pots (ground only, no hanging baskets limited to no more than 2 pots) and figurines that are less than 3 feet in height. They may be placed in landscape beds, on porches, patios, or on driveways adjacent to garage door opening. No decorative objects, shrubs, plantings or curbing material is permitted at either side of driveway. All objects are to be neutral tone. (brown, tan, gray)

**DRIVEWAYS, WALKS, PORCHES, PATIOS:** Any replacements require an application to and approval by the association, Driveways are considered permeable, and cannot be sealed.

**EMERGENCY GENERATORS:** are permitted subject to an application to approval of the association and required local authorities.

**ENTRY DOORS:** Replacement of front and rear doors, requires an application to and approval of the association. Color, style, hardware, operation and manufacturer to match that as specified by the association. For storm doors, see requirements on page 3.

**FENCING:** Fencing of any type (including hedges) is not permitted to be constructed, erected, installed or planted on any lot with the exception of fencing as deemed necessary by the association.

**FIREPLACES:** Any installation of a new fireplace, either within or outside of a unit, requires the application to and approval of the association.

**FLAGPOLES:** Flagpoles are permitted, either attached to the front of the house or garage or freestanding. Freestanding poles must not impede lawn maintenance and/or the irrigation system and may not exceed 20 feet in height.

**GARBAGE/ REFUSE CONTAINER ENCLOSURES:** are not permitted. Refuse and recycling containers are to be stored within the unit until placed at designated pick up areas.

**GARAGE DOORS:** Replacement of garage doors requires an application to and approval by the association. Color, style, hardware and manufacturer to match that as specified by the association.

**GARDENS:** (for growing vegetables, fruits or herbs) are to be located on the side or rear of the house and cannot extend more than three feet from the house. Gardens are not permitted in the front of the house and cannot be located on the street side of homes located on a corner lot. Placement of the garden along the side of the house must be at least ten feet from the front of the house.

GAZEBOS: whether permanent or temporary, are not permitted on any lot, porch, or patio.

**GRILLS:** Portable outdoor cooking grills are permitted, but cannot be used within 5 feet of any exterior wall. When not in use, grills must be stored on the rear patio covered or within garage so as not to impede lawn maintenance equipment.

**HOLIDAY DECORATIONS:** Holiday decorations may be displayed no earlier than 30 days before and remain no more than 30 days after a specific holiday.

**LANDSCAPE WALLS/GARDEN WALLS:** are not permitted, unless the topography/ slope of an individual lot dictate a wall. An application to and approval by the association is required for the construction of any landscape walls.

**OUTDOOR CARPET:** Weather-resistant removable temporary outdoor area carpets are permitted on patios and porches. Must be neutral tones. (brown, gray or tan)

**PARKING OF VEHICLES:** In addition to owner's garage and driveway, cars may only be parked in designated parking areas so as not to impede general street traffic, mail delivery and the clear passage of pedestrians on the sidewalk. **Parking along roadways is not permitted.** 

**PARKING OF COMMERCIAL VEHICLES:** No commercial vehicles larger than panel trucks, motor homes, recreation vehicles, boats and trailers are permitted to park within Autumn Ridge at Manchester,

except those vehicles temporarily within the community for the purpose of servicing the community or one of the units.

**PATIO FURNITURE:** is allowed on porches and patios. Must be neutral tones and weatherproof. Furniture must be sized to fit appropriately on porch or patio.

**PATIOS:** Changes to the original patio or new patios require an application to and approval by the association and local authorities.

PETS: are permitted subject to restrictions explained in the PC Bylaws.

**PET DOORS:** or other openings that allow pets to enter or exit a house are not permitted.

**PORCHES:** ANY changes to the entry porches are not permitted, including enclosures.

**RECREATION EQUIPMENT** – OUTDOOR PERMANENT: is not permitted. This includes, but is not limited to, playground equipment, basketball hoops, exercise/fitness equipment, tennis equipment, sports practice cages, or whirlpool spas.

**ROOM EXTENSIONS:** added to the existing under-roof framework or overhangs are not permitted.

**SATALITE DISAHES/RADIO ANTENNAS:** Must be approved by the Board in advance and are only permitted (adjacent to rear patio) In certain limited common areas on rear of home.

**SIDING/TRIM/SHUTTERS:** Any changes or replacement to the existing siding, trim, or shutters, other than emergency repair, requires an application to and approval from the association.

**SIGNS:** Real Estate signs advertising the property for sales may be located on a door or window only. Construction Contractor and Political signs of any kind are not permitted.

**SOLAR PANELS:** are not permitted.

STORAGE SHEDS: of any kind are not permitted.

**STORM DOORS:** Installation or replacement of storm doors requires an application to and approval of the association. Permitted Storm Door is a "LARSON Signature Classic White Full-View" available at the local Lowes Item # **758239** Model # **14904032** 

TENTS: of any type, whether temporary or permanent, are not permitted.

WINDOW AIR CONDITIONERS: are not permitted.

WINDOW BOXES: are not permitted.
